## UVOD

Godišnji izveštaj Ekumenske humanitarne organizacije za 2011. godinu predstavlja presek događaja relevantnih za organizaciju, ranjive grupe sa kojima je organizacija sarađivala, razvoj lokalne zajednice i proces socijalne inkluzije u Srbiji.

EHO je tokom 2011. godine nastavila sa realizacijom programa i projekata sa ciljem osnaživanja ranjivih grupa u društvu i na taj način podržala proces socijalne inkluzije u Srbiji.

Razvoj i osnaživanje jedinstvene mreže dijakonijskih grupa u Vojvodini je nastavljen. Usluge Kućne nege su unapređene. Ekumenska saradnja je tokom 2011. godine promovisana kroz program Škole ekumenizma.

Projekat EHO „Socijalna inkluzija i poboljšanje uslova stanovanja

Roma i Romkinja u AP Vojvodini, R. Srbiji“, za koji je organizacija dobila evropsku nagradu 2010. godine, ušao je u petu godinu realizacije. Uspostavljeno je partnerstvo sa opštinom Bečeј, a ključnu ulogu je imalo 560 Roma i Romkinja koji/e žive u romskim naseljima u Bečeju i Bačkom Gradištu.

Ekumenska humanitarna organizacija je bila jedini učesnik iz Srbije na Prvom internacionalnom forumu za stanovanje. Takođe, EHO osoblje je tokom cele godine učestvovalo u radu relevantnih radnih grupa i na taj način je naša organizacija dala doprinos razvoju nediskriminatorskih politika.

Pored dugogodišnje saradnje sa internacionalnim partnerima, EHO je uspela da obezbedi sredstva iz novih izvora finansiranja, kao što su fondovi Evropske unije. Ovim sredstvima realizovani su projekti za unapređivanje radnih prava osoba sa invaliditetom, kao i utvrđivanje načela nediskriminatorne javne politike o deci uključenoj u život i/ili rad na ulici.

U narednom periodu, EHO će nastaviti da razvija svoje usluge i servise, kreira nove inicijative i učestvuje u daljem procesu demokratizacije društva.

# INTRODUCTION

The 2011 Annual Report of the Ecumenical Humanitarian Organization (EHO) is a shortlist of activities and events relevant both for the organization, as well as for the vulnerable groups it has been collaborating with, the development of the local community and the social inclusion process in Serbia.

In 2011 EHO continued with the implementation of programs and projects aimed at empowering vulnerable social groups, facilitating thus the social inclusion process in Serbia.

It continued developing and empowering its unique network of diaconal volunteer groups all over Vojvodina, whereas the home care service had also been upgraded. Ecumenical collaboration was promoted throughout 2011 also by the special design of the last year's School of Ecumenism curriculum.

The Social Inclusion and Improvement of Housing Conditions for the Roma Men and Women in the Autonomous Province of Vojvodina, Republic of Serbia Project, which made EHO the winner of the Eurodiaconia Prize in 2010, entered its

fifth annual implementation cycle in 2011. A partnership was established with the Municipality of Bečej, with 560 Roma men and women in the Roma settlements in Bečej and Bačko Gradište playing a key role throughout the process.

Ecumenical Humanitarian Organization was the only representative of Serbia at the First International Housing Forum. EHO staff were also members of the relevant working groups throughout the year, so our organization was in a position to contribute to development of non-discriminatory policies as well.

Besides continuing its long-lasting collaboration with its international partners in 2011, last year EHO accessed some new funding sources, such as EU funds. These funds provided for implementation of projects improving employment rights of people with disabilities, as well as establishing principles of non-discriminatory public policies concerning children living and/or working in the street.



EHO would like to express its gratitude and appreciation to all its staff, volunteers and beneficiaries whose engagement contributed to its successful work in 2011. We would also like to thank all representatives of the local self-governments, provincial and national institutions, as well as our partners from Switzerland, Germany, the Netherlands, Austria, Norway and the USA for their support.

In the forthcoming period EHO will continue developing its services, creating new initiatives and participating in continued democratization of the society.

Ecumenical Humanitarian Organization (EHO) is a non-profit citizens' association continuing the work of the Ecumenical Humanitarian Service founded by the World Council of Churches (WCC) on 19 February 1993.

Its founder churches are:

- The Slovak Lutheran Church in Serbia;
- The Reformed Christian Church in Serbia;
- The Methodist Church in Serbia;
- The Greek Catholic Apostolic Exarchy in Serbia and Montenegro;
- The Lutheran Church in Serbia.

Ever since its foundation EHO has been a regional example of inter-church collaboration in diaconal activities all over Vojvodina. EHO testifies about the churches' mission in working with the poor and marginalized.

Its unique network of diaconal groups connecting 500 volunteers of diverse confessions has become a EHO's trademark in Vojvodina, only to prove that even traditional structures, such as churches, represent a driving force in civil society development.

Today's EHO has a reputation of an organization that deals with general social problems. Furthermore, EHO has a pioneering role in creating initiatives that contribute to solving social welfare problems and facilitating the work of other organizations since

Alongside other civil society organizations, EHO has so far raised many issues significant for the life of citizens of Serbia, including peace and reconciliation, ecumenical collaboration, solidarity, volunteering, but most of all people's awareness-raising on their responsibility and ability to respond to social problems in a constructive way.

EHO changed as well by changing its environment. The organization's development directions, its capacities and resources were presented in EHO's Strategic Plans of 2002, 2006 and 2010. EHO proved to be an open and flexible organization, responding successfully to its own and general social challenges in its environment posed by the continuous social reform, democratization and EU integration processes in Serbia.

In 2010 EHO has adapted its Statute to the requirements of the newly adopted Law on Associations and its re-registration finished in August 2010.


- doprinos razvoju civilnog društva kroz zastupanje prava, socijalnu inkluziju i razvijanje potencijala ugroženih grupa;

## Asistivne tehnologije kao način unapređivanja radnih prava osoba sa invaliditetom

Asistivne tehnologije u kontekstu ovog projekta podrazumevaju različita kompjuterska rešenja (opremu i programe) koja poboljšavaju kvalitet života osoba sa ograničenim sposobnostima kretanja i komunikacije, kao i osoba sa oštećenim senzornim i mentalnim funkcijama. Predstavnici i predstavnice 20 organizacija civilnog društva (OCD) sa područja Vojvodine su tokom projektnog perioda poхађali treninge o osnovama asistivnih tehnologija i javnom zastupanju prava na rad osoba sa invaliditetom u međunarodnom i domaćem pravnom kontekstu. Učesnici i učesnice iz neformalne mreže ovih organizacija pokrenuli su i Inicijativu da se asistivne tehnologije integrišu u tržište rada.

Imajući u vidu važnost asistivnih tehnologija u ostvarivanju prava na rad osoba sa invaliditetom, rezultat ove Inicijative je i dokument sa relevantnim predlozima za njeno sproveđenje. Uz 24 OCD, Inicijativu je podržalo i nekoliko relevantnih pokrajinskih i republičkih institucija i tela: Pokrajinski ombudsman, Pokrajinski sekretarijat za privredu, zapošljavanje i ravnopravnost polova i Tim za socijalno uključivanje i smanjenje siromaštva Vlade R. Srbije.

## Assistive Technologies As a Means of Advancing Employment and Labor Rights of People With Disabilities

In the context of this project, assistive technologies imply various IT solutions (hardware and software) that improve the quality of life of people with limited mobility or communication skills, as well as that of people with sensory impairments or limited mental capacities. During the project period, representatives of 20 civil society organizations in Vojvodina attended training on assistive technologies basics and advocating employment and labor rights of people with disabilities within the context of the international and local legal framework. Participants from the informal network of these organizations have started an Initiative to integrate assistive technologies into the labor market. Bearing in mind the significance of assistive technologies in exercise of employment and labor rights of people with disabilities, the result of this Initiative is also a document with relevant suggestions for its implementation. Along with 24 civil society organizations, the initiative has been supported by several relevant provincial institutions and national governmental bodies: the Provincial Ombudsman of Vojvodina, the Provincial Secretariat for Industry, Employment and Gender Equality and the Social Inclusion and Poverty Reduction Team of the Government of the Republic of Serbia.

## Pomoć prisilno raseljenim Romima i Romkinjama

Tokom 2011. nastavljena je realizacija projekta čiji je cilj da se putem pravne, ekonomске i obrazovne pomoći, kao i poboljšanja uslova stanovanja, podrži proces (re)integracije Roma i Romkinja koji su vraćeni u Srbiju iz zemalja zapadne Evrope u kojima su izgubili pravo boravka, kao i Roma i Romkinja koji su raseljeni sa Kosova, a borave u nekoj od vojvođanskih opština. U 2011. godini pribavljeno je 659 različitih ličnih dokumenata, 46 porodica je dobilo bespovratnu pomoć za započinjanje malog biznisa (u vidu alata, opreme i tromesečnih stručnih kurseva), 79 dece je pohađalo pripremnu, odnosno dopunsku nastavu i dobilo školski pribor i obuću, a uslovi stanovanja su poboljšani u 12 romskih kuća.

## Assistance to Evicted Roma Men and Women

In 2011 this project continued to provide legal and material aid, financial support, education and housing conditions improvement in support of (re)integration processes for the Roma men and women who had been returned to Serbia both from Western European countries where they had lost their right of residence, as well as to those displaced from Kosovo. Aid was provided to those residing in municipalities in Vojvodina. The beneficiaries were provided with 659 various documents in 2011, while 46 families were supported in starting their own small business by means of providing them with tools, equipment and three-month training courses. Preparatory or supplementary teaching, as well as school supplies and clothes were provided to 79 schoolchildren, whereas housing conditions had been improved in 12 Roma houses.

## Ka sveobuhvatnom sistemu za suzbijanje nasilja nad ženama u AP Vojvodini

Trogodišnji projekat koji ima za cilj obezbeđivanje potpunog poštovanja ljudskih prava žena putem uspostavljanja efikasnog sistema prevencije porodičnog i rodno uslovljenog nasilja, kao i zaštite i podrške ženama žrtvama nasilja. Tokom treće godine

sprovođenja projekta organizovano je ukupno 88 treninga namenjenih razvoju kapaciteta profesionalaca i profesionalnki u svim relevantnim institucijama u opštinama na teritoriji

AP Vojvodine. Ovaj partnerski projekat sprovode Pokrajinski sekretarijat za privredu, zapošljavanje i ravnopravnost polova Vlade AP Vojvodine, Autonomni ženski centar, Viktimološko društvo Srbije, Centar za socijalni rad opštine Sombor i Ekumenska humanitarna organizacija, a uz podršku Fonda Ujedinjenih nacija za borbu protiv nasilja nad ženama.

## Towards a Comprehensive System of Combating Violence Against Women in the Autonomous Province of Vojvodina

This is a three-year project aimed at providing full respect of women's human rights by establishing an efficient system of prevention of domestic and gender based violence, as well as that for protection of and support-provision to women having experienced domestic violence. The major activity of the third project year were 88 capacity building trainings delivered to professionals from all relevant town and municipal level institutions in the Autonomous Province of Vojvodina (APV). This project is a partnership venture of the Provincial Secretariat for Industry, Employment and Gender Equality of the APV Government, the Autonomous Women's Centre, the Serbian Victimology Society, Social Welfare Center of the Town of Sombor and EHO funded by the UN Trust Fund to End Violence Against Women.

## Jačanje socijalne kohezije putem razvoja nediskriminatorene javne politike za decu uključenu u život i/ili rad na ulici

Cilj ovog projekta je podsticanje socijalne kohezije i prevazilaženje diskriminacije u društvu povećanjem vidljivosti dece uključene u život i/ili rad na ulici, kao i razvoj nediskriminatorene javne politike u odnosu na ovu grupu dece.

Tokom 2011. su realizovane četiri komponente ovog projekta:

1. terensko istraživanje o deci koja žive i/ili rade na ulici,
2. podizanje svesti lokalne zajednice o ovoj temi putem javne kampanje,
3. jačanje multisektorske saradnje u cilju rešavanja problema u ovoj oblasti na lokalnom nivou,
4. utvrđivanje načela nediskriminatorene javne politike u ovoj oblasti i njihovo objavljanje.

Partneri EHO u ovom projektu su Katedra za psihologiju Univerziteta u Novom Sadu i Fond za razvoj neprofitnog sektora Autonomne Pokrajine Vojvodine. Rezultat ovog projekta je i potpisivanje Protokola o međusektorskoj saradnji kojim je deci koja žive i/ili rade na ulici omogućen pristup uslugama sistema zdravstvene zaštite.

## Strenghtening Social Cohesion by Means of Developing a Non-Discriminatory Public Policy for Children Involved in Living and/or Working in the Streets

The aim of this project is facilitating social cohesion and overcoming social discrimination by increasing the visibility of children involved in living and/or working in the streets, as well as by developing a non-discriminatory public policy concerning this group of children. The following four project components have been implemented in 2011:

EHO partners in this project were the Psychology Department of the Faculty of Philosophy with the University of Novi Sad and the Non-Profit Sector Development Fund of the Apv Government. Another result of this project has been the signing of the Inter-Sectoral Collaboration Protocol, a document providing access to the healthcare system to children living and/or working in the streets.

1. Field research study on children living and/or working in the streets;
2. Local community awareness-raising campaign in this issue;
3. Strengthening multi-sectoral collaboration aimed at problem-solving in this field at the local level;
4. Determining the principles of the non-discriminatory public policy in this field and their publication.

## RakInfo - Služba podrške obolelima od raka

Redovne aktivnosti Službe su pružanje informacija i emocionalne podrške obolelima od raka telefonom i lično, kao i organizovanja programa „Družilišta”, a koje okuplja osobe koje je rak na razne načine dotakao. Uz proširivanje „Zida nade“ na kom je izloženo još oslikanih keramičkim pločicama inspirisanih iskustvima naših klijenata i klijentkinja, RakInfo je tokom svojih javnih akcija i distribucijom štampanog informativnog materijala nastavio edukaciju stanovništva Vojvodine u oblasti prevencije i ranog otkrivanja raka. Služba je nastavila da razvija i intenzivnu međunarodnu saradnju sa sličnim organizacijama u Evropi, a ovim putem je obezbeđena i značajna donaciju perika za žene koje su izgubile kosu usled hemoterapije.

## CancerInfo - Information and Support Service for Cancer Affected

The service provides information and emotional support to cancer affected people. Such support is available on regular basis by phone and in person, as well as in the Social Club program that brings together people affected by cancer in various ways. Along with expanding the Wall of Hope displaying more painted ceramic tiles inspired by the experience of our clients, CancerInfo continued its education activities on cancer prevention and early detection by means of organizing public actions and distributing printed info materials throughout Vojvodina. The Service continued developing its intensive international collaboration with similar organizations in Europe, which provided for a major donation of wigs for women who lost their hair due to chemotherapy.

## PROGRAMI

### Dijakonijski centar

Dijakonijski centar je 2011. godine nastavio da radi na unapređenju kvaliteta života starih i bolesnih u Novom Sadu, Kisaču, Pivnicama i Staroj Pazovi. Oko 300 korisnika službe kućne nege i pomoći u kući primilo je profesionalnu pomoć medicinskih sestara i negovateljica, a uvedena je i popodnevna smena, kao i rad vikendom i praznicima u Novom Sadu. Volontersku službu psihosocijalne podrške koristilo je 43 ostarelih i usamljenih lica u Novom Sadu. Starijim sugrađanima i sugrađankama je u Novom Sadu na raspolaganju bio i Klub za seniore, a čije usluge je koristilo 220 osoba. Tokom 2011. godine naročita pažnja bila je posvećena volonterima i volonterka širom Vojvodine. Povodom Evropske godine volontera za njih su organizovani i nagradni kursevi. Dijakonijski centar je, u okviru mreže Centar za pomoć starim licima u Novom Sadu, organizovao i seminare za zaposlene u službama kućne nege. Socijalno najugroženijim osobama u Novom Sadu i okolini obezbeđivana je polovna odeća i obuća, a na rasploaganju im je bila i vešernica u EHO centru.



### Diaconal Center

In 2011, the Diaconal Center continued working on improvement of the quality of life of the elderly and ill people in town of Novi Sad and three smaller settlements (Kisač, Pivnice and Stara Pazova). Around 300 beneficiaries of home care services were assisted by professional nurses and caretakers. An additional service introduced in 2011 was the afternoon shift, as well as working on weekends and holidays in Novi Sad. Volunteer services were being provided to 43 elderly and/or lonely people in Novi Sad throughout 2011, while the Senior's Club in Novi Sad was available to them and used on daily basis by 220 people. Volunteers were in special focus and various courses were provided to them since 2011 was the European Volunteers' Year. Within the Network for Assisting the Elderly in Novi Sad, the Diaconal Center also organized trainings for employees of the home care service. The socially vulnerable people in Novi Sad and its vicinity were also provided with second-hand clothes and footwear, while the EHO Laundry Service was at their disposal throughout the year.

## Romski resursni centar

Romski resursni centar je tokom 2011. realizovao osam projekata. Projekat „Socijalna inkluzija i poboljšanje uslova stanovanja Roma i Romkinja u Bačkom Gradištu i Bečeju, Opština Bečeј“ realizovan je u saradnji sa Opština Bečeј i Kancelarijom za inkluziju Roma

Vlade AP Vojvodine. EHO RRC je zajedno sa 118 porodica u Bačkom Gradištu i Bečeju za njih obezbedio sanitarni minimum (izgradio septicke jame, sazidao i opremio kupatila), dok je 11 porodica saniralo oštećene delove kuća i/ili izgradilo jednu manju kuću od polovnog građevinskog materijala.

EHO RRC je tokom 2011. sarađivao sa pedagoškim asistentima i asistentkinjama u 12 vojvođanskih osnovnih škola, organizovao mentorски rad, vannastavne aktivnosti, kao i rad sa roditeljima.

Romi i Romkinje su učestvovali/e i u programu radnog osposobljavanja, zapošljavanja i samozapošljavanja, a tokom organizovanih terenskih posete pravnika Centra bili/e su u mogućnost i da ostvare neka od svojih zakonom zagarantovanih prava. Različite usluge Centra je toom 2011. koristilo 8.265 osoba, a uz pomenute aktivnosti realizovane su još i akcije javnog zagovaranja i lobiranja u oblasti ostvarivanja prava na adekvatno stanovanje i legalizaciju romskih naselja.

## Roma Resource Center

In 2011, the EHO RRC implemented eight projects. The Social Inclusion and Improvement of Housing Conditions of the Roma in Bačko Gradište and Bečeј, the Municipality of Bečeј project was implemented in collaboration with the Municipality of Bečeј and the Roma Inclusion Office of the APV Government. In collaboration with 118 families in Bačko Gradište and Bečeј, EHO RRC provided them with a sanitary minimum (i.e. constructed septic tanks, built and equipped bathrooms in their houses), whereas 11 families had their dilapidated houses partially repaired and/or a small house built from second-hand building material.

EHO RRC also collaborated with pedagogical assistants in 12 primary schools in Vojvodina, where it organized mentoring work, extracurricular activities, as well as working with parents. Roma men and women participated in vocational trainings and (self-)employment programs, while the field visits of the lawyer employed by the EHO RRC provided some of them with an opportunity to exercise some of their rights granted by the law. The Centre provided its services to 8,265 people in 2011, along with some advocacy and lobbying activities in the field of adequate housing and legalization of Roma settlements.

## Resursni centar za osobe sa invaliditetom

Usluge RCOSI je tokom 2011. u 4.632 navrata koristilo 190 osoba sa invaliditetom (OSI). Cilj rada ovog centra je socijalno uključivanje OSI, a Centar teži to da postigne organizovanjem raznih kurseva: rada na računaru, engleskog jezika, tkanja, šivenja, slikanja na staklu, gestovnog govora, aranžiranja cveća, kuvanja, poslastičarstva, izrade nakita i štrikanja prstima. Svi kursevi su imali za cilj povećanje konkurentnosti OSI na tržištu rada. Tokom 2011. je, uz obuku novih saradnika, organizovan i assertivni trening za OSI, odštampana su tri broja časopisa „Linker“, a organizovan je i besplatan prevoz za OSI u Novom Sadu. Stalne aktivnosti Centra predstavljaju i pružanje psihosocijalne podrške OSI i članovima njihovih porodica, usluge pravnog savetovanja, savetovanje u vezi sa asistivnim tehnologijama, kao i posredovanje u vezi sa zapošljavanjem OSI.

## Resource Center for People with Disabilities

---

In 2011, the services of RCPWD were used by 190 people with disabilities (PWD) on 4,632 occasions. The main aim of the Centre is social inclusion of PWD and it strives towards it by providing various training courses, such as computers, English, weaving, tailoring and sewing, glass painting, sign language, flower arranging, (pastry) cooking, cake decoration, jewelery making and finger knitting. The purpose of all these courses was increasing the competition potential of PWD in the labor market. Along with a training for new staff, the Center provided an assertiveness training for PWD. Three numbers of the Linker were issued, and PWD in Novi Sad were provided free car transportation by the Center. Ongoing activities of the Centre were also psychosocial support provision to the PWD and their family members, free legal aid, consultancy concerning assistive technologies, as well as mediation in PWD employment processes.

## Program for Children Living and/or Working in the Streets

In 2011, the Drop-in Center provided food and clean clothes, possibilities of maintaining personal hygiene, basic medical assistance, as well as consultations with a psychologist, pedagogist and a social worker to 648 children living and/or working in the streets. Linking children with the institutions in charge, educational and creative workshops were also some of the regular activities of the Drop-in Center, along with an extensive field work in order to make the services of this program accessible also to those children who rarely or never come to the Center.



MİŞJENJE NEZAVISNOG REVIZORA

*Uvod*

1. Izvršili smo reviziju bilansa stanja Ekumenske humanitarne organizacije, Ulica Čirila i Metodija br. 21., Novi Sad (u daljem tekstu: EHO) na dan 31. decembra 2011. godine u bilansa uspeha za tu poslovnu godinu koji su prikazani na stranama 3 do 4, kao i pregled značajnijih računovodstvenih politika i drugih objašnjavačih napomena. Prema računovodstvenim propisima mala pravna lica nisu u obavezi da dostavljaju izveštaj o tokovima gotovine, stoga ovaj Izveštaj nije pripremjen.

*Odgovornost rukovodstva za finansijske izveštaje*

2. Rukovodstvo EHO je odgovorno za pripremu i poštenu prezentaciju ovih finansijskih izveštaja u skladu sa računovodstvenim propisima Republike Srbije. Ova odgovornost obuhvata: osmišljavanje, primenu i održavanje internih kontrola koje su relevantne za pripremu i poštenu prezentaciju finansijskih izveštaja koji ne sadrže materijalno značajne pogrešne iskaze nastale usled kriminalne radnje ili greške; odabir i primenu odgovarajućih računovodstvenih politika i računovodstvene procene koje su razumno u skladu sa okolnostima.

*Odgovornost revizora*

3. Naša odgovornost je da, na osnovu izvršenih ispitivanja, izrazimo mišljenje o prikazanim finansijskim izveštajima. Reviziju smo izvršili u skladu sa Zakonom o računovodstvu i reviziji, Međunarodnim standardima revizije (MSR -ISA) i Kodексom etike za profesionalne računovođe. Ova regulativa nalaže da reviziju planiramo i izvršimo na način koji omogućava da se u razumnoj merni uverimo da finansijski izveštaji ne sadrže materijalno značajne pogrešne iskaze. **INDEPENDENT AUDITOR'S REPORT**

*Introduction*

1. We have audited the accompanying balance sheet of Ecumenical Humanitarian Organization, street Čirila i Metodija No 21, Novi Sad, Serbia (in further text: EHO), as of 31 December 2011, the related statement of income, that are set out on pages 2 to 3. According to Serbian accounting regulations, small sized companies are not required to prepare a cash flow statement, thus this statement have not been prepared.

*Management's Responsibility for Financial Statements*

2. Management is responsible for the preparation and fair presentation of these financial statements in accordance with Serbian accounting regulations. This responsibility includes: designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

*Auditor's Responsibility*

3. Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with the Serbian Law on Accounting and Auditing, International Standards on Auditing (ISA) and Code of Ethics for Professional Accountants. These regulations require that we plan and perform the audit to obtain reasonable assurance whether the financial statements are free from material misstatement. An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating estimates made by management, as well as evaluating the overall presentation of the financial statements.

*Opinion*

4. In our opinion, the financial statements present fairly, in all material respects, the financial position of Ecumenical Humanitarian Organization as of 31 December 2011 and the results of its operations for the year then ended, in accordance with the International Accounting Standards and Serbian accounting regulations, in the manner disclosed in the Notes to the Financial Statements.

*Other Matters*

5. The financial statements for the previous year has been audited by another audit company in which report the opinion were unqualified.
